Annual Congregational Meeting
January 26, 2025

The meeting was called to order by Moderator Ben Crosby at 10:26 a.m. Alice Ling led an opening prayer.

A quorum of 5 was necessary, and Ben declared a quorum with 8 active members and 3 guests present. Geri Bair was reinstated as an active member by Board consensus.

The agenda was adopted and voices granted to friends of the church.

Minutes of the last annual meeting and the special budget meeting were reviewed. Nancy Branstetter moved, and Rick Ehram seconded that we accept both sets of minutes; the motion carried.

Annual Reports

- Supply Pastor
 - Alice Ling asserted her commitment to keep things going, but preparation for worship is more challenging. She hopes guest pastors have been a welcome addition. She would love to hear feedback regarding the remote sermon we had in December.
- Moderator
 - Like Alice, Ben expressed that he thought he would step back from leadership roles. He is concerned about the future of this church. We are doing well now, but we will need more leadership going forward.
- Clerk
 - Membership has dropped from 35 to 20.
- Treasurer
 - Available equity is down around \$5,000 from 2023. The Corinthians group has not been active for several years. The checking account was closed and \$2,700 was added to the main UCC account. The money remains identified in our funds.

Election of Leadership

Rick is transitioning to Treasurer following Ben's ~15 years of service. The leadership roster was proposed as follows:

- Moderator – Benjamin Crosby (term ends at the end of the January 2026 annual meeting.)
- Clerk – Katie Bauer (terms ends at the end of the January 2027 annual meeting.)
- Treasurer – Benjamin Crosby transitioning to Rick Ehram (term end at the end of the January 2028 annual meeting.)
- Executive Board at-large – Rick Ehram (term ends at the end of the January 2027 annual meeting); Gail Carlson (term ends at the end of the January 2028 annual meeting); one vacant seat.

It was moved by Nancy and seconded by Geri Bair that we accept the leadership roster; motion carried.

Ben presented the 2025 budget. He explained that we are in the red, but we typically underspend our budget. It was moved by Rick and seconded by Nancy that we accept the budget; motion carried.

The Pacific Northwest Conference Annual Meeting will take place April 25th-27th at the Yakima Convention Center. Rick expressed interest and he and Gretchen will check their calendar.

Alice Holmes offered her thanks to Alice Ling and the Executive Board.

Alice Ling led a closing prayer.

Meeting was adjourned at 10:55 a.m.

Budget Meeting Minutes
November 16, 2025

The meeting was called to order by Moderator Ben Crosby. Members Ben Crosby, Alice Ling, Geri Bair, Rick Ehram, Gretchen Ehram, Gail Carlson, Katie Bauer, and Nancy Branstetter were present.

Alice asked for feedback regarding the Christmas Eve service. Members agreed that we would like to have a service, but no preference for morning or evening.

Ben presented our budget for 2026. He highlighted the unexpected income we received from the Seventh Day Adventists, but that is not expected to continue for 2026. Ben explained that we have not heard anything regarding our grant application. The grant proposal includes part-time positions shared between UCC Verdale, N-Sid-Sen, and our church. If approved, we would pay a pastor salary and benefits for six months in 2026 and a supply pastor salary for the other six months. Ben pointed out that our proposed expenses would deplete our savings, but the board feels that this will be an investment in our future. There was a short discussion. The budget will be voted on at the annual meeting January 25th.

The following changes to the Bylaws of the church are proposed by action of the Executive Board taken December 19, 2025 and communicated to the congregation by letter dated January 11, 2026.

(Additions are indicated in red. Deletions are struck through.)

CONSTITUTION

Article VI. – Membership

Membership in this church shall be open to any person who has been baptized, has been confirmed, or has made public confession of faith in Jesus Christ.

Members shall pledge themselves to attend the regular worship of the church and the celebration of the Lord's Supper; to live the Christian life; to share in the life and work of the church; to contribute to its support and benevolences; and to seek diligently the spiritual welfare of the membership and the community.

BYLAWS

Section 1. – Membership

Any person desiring to join in the ministry of this church, embracing the purpose as stated in Article IV of the Constitution, may be admitted to the membership of this church by baptism, confirmation, letter of transfer from another church, or reaffirmation of faith.

All members, including Associate Members (see below), are encouraged to take part in the joy and fellowship of congregational life and share in the responsibility of supporting the work and mission of the church. The following principles will govern membership:

1. All members will be classified as “active members” as long as they are present **as best they are able** (i.e. regular in their attendance in worship and/or support the church with their time, talents and/or treasure).
2. **The Executive Board is responsible for overseeing the church membership list. When members have not been active (as described above) for a period of one year, the Executive Board may in their sole discretion classify them as “inactive members” or drop them from the church roles.**
3. ~~Members will be classified as “inactive members” when they have not been present in the church's life for a period of two years.~~
4. ~~Members may be dropped from the rolls when they have been absent from the church's life for a period of four years and have not responded to efforts by the church and/or the Pastor to reach out to them.~~
5. Associate Members are those who hold their primary church membership elsewhere but wish to affiliate with this church. They will be identified as such on the membership list.
6. Any member may request a transfer to another church.
7. Any member may request that their membership be dropped at any time.

~~The Executive Board is responsible for overseeing the membership list.~~ The Clerk is responsible for maintaining the membership records.
